- (iii) A certificate / undertaking on stamp paper of relevant value that the Bidder or its firm/company is never blacklisted by any Government or Semi-Government Department (i.e. PPRA, FBR, PRA, etc.).
- (iv) Other documentary requirements mentioned in the Bidding Documents/TORs.
