EOI Applications submitted or received after the closing time shall be rejected. The procurement process will be governed under the Punjab Procurement Rules, 2014 as amended from time to time.

The procurement of services would be for a term of three years subject to satisfactory performance review by Finance and Audit Committee and Board of Directors, at end of each year. It would also be subject to appointment by shareholders each year in Annual General Meeting as per Companies Act, 2017.
