Quaid-e-Azam Thermal Power (Private) Limited invites sealed Applications for prequalification of potential Bidders for Operations & Maintenance Works / Services of the subject Power Plant.

**Employer:** QATPL is a private limited company, wholly owned by Government of Punjab, Pakistan and incorporated under the Companies Ordinance 1984.

**Power Plant:** A base-load 1180 MW (Gross) Combined Cycle Power Plant.

**Location:** Bhikki, 18 km from Sheikhupura, Punjab, Pakistan.

**Primary Fuel:** Re-Gasified Liquefied Natural Gas (RLNG) to be supplied by Sui Northern Gas Pipelines Limited (SNGPL).

**Backup Fuel:** High Speed Diesel (HSD).

**Configuration:** Two (02) General Electric (GE) Frame 9HA.01 Gas Turbines, Two (02) Hangzhou BG Heat Recovery Steam Generators and One (01) Alstom Steam Turbine.

**Tentative Commissioning Schedule:** Phase 1 – Simple Cycle Commercial Operation for both GTs in Q1 / Q2 2017.

Phase 2 – Combined Cycle Operations in Q4 2017.

A Long Term Service Agreement (LTSA) has been signed with GE (GT Original Equipment Manufacturer). O&M for Phase 1 (Simple Cycle Operations) has been handed over to the EPC Contractor. Now, QATPL intends to hire the services of a reputed O&M Contractor for Operations & Maintenance Works / Services of the subject Power Plant in Phase 2 (Combined Cycle Operations) of the project. The O&M Contractor shall work in close association with the EPC Contractor during the commissioning activities and in liaison with the LTSA Contractor during Combined Cycle Operations of the project.

Domestic Applicants / domestic JV partners should be on the Active Taxpayer list of FBR.
