- NTN and Sales Tax registration certificate (in case of exemption, proof should be annexed with the bid)
- Affidavit declaring that the company firm is not blacklisted by any Government Department/ Authority/ Agency/ Company
- The procurement procedure shall be **Single Stage Two Envelopes** as per Punjab Procurement Rules 2014. This procurement will be governed by the Punjab Procurement Rules, 2014 which may be downloaded from the website www.ppra.punjab.gov.pk.
- A refundable bid security/CDR of Rs.36,000/- to be submitted with the bids.
- Procuring agency may reject all the bids any time prior to acceptance of any bid as laid down in Section 35 of the Punjab Procurement Regulatory Authority Rules, 2014.
- The interested bidders shall submit the bid in a single package consisting two separate sealed envelopes marked as “Technical Proposals” and “Financial Proposals”, containing name of

- The technical & financial bids will be opened on the same day at **03.30 p.m.** by the Procuring Committee in presence of the authorized representatives of the firms.
