TENDER DOCUMENT / TORS FOR HIRING OF SECURITY FIRM FOR PROVISION OF SECURITY GUARDS

1. Invitation to Bid

Quaid-e-Azam Thermal Power (Pvt.) Ltd. (“QATPL”) invites sealed bids from eligible bidders/firms for the provision of “SECURITY GUARDS” at Head Office and its Project Site situated at Bhikki, Sheikhpura or at any other place as required by QATPL.

1.1 Mode of Advertisement(s)

This Tender is being placed online on company / PPRA's website, as well as being advertised in Newspapers. The bidding document can be obtained from QATPL's Head Office situated at First Floor, 7-C-1, Gulberg III, Lahore.

1.2 Type of Bidding

- i. Bidding process is open competitive bidding and will be carried out through Single Stage - Two Envelope Procedure. The bidder must submit their proposals in a single package containing two separate envelopes clearly marked as” **Technical Proposal**” and” **Financial Proposal**” in response to the advertisement.
- ii. The technical proposal will be evaluated in a manner as per the evaluation criteria for shortlisting of private security companies attached as **Annex-A** to this document; and proposals which do not conform to the specified requirements as listed in said document will be rejected.
- iii. During the technical evaluation no amendments in the technical proposal shall be permitted;
- iv. The Financial Proposal of technically qualified bidders shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance;
- v. The technically qualified bidder with lowest financial bid will be the successful bidder.

2. The Security Services shall include the following:

3. The number of Security Guards may decrease according to the need of company.
4. The Bidder will provide Four (04) Number of Armed Security Guards for Head Office (Lahore) and their duty shifts will be Three (3) for day and One (01) for Night.

5. Ten (10) Number of Security Guards Cum Supervisors will be provided at Project Site (Bhikki, Sheikhupura) and their duty shifts will be according to the requirement of QATPL
6. Duty timing will be Twelve (12) hours.
7. Ammunitions, Uniforms and other necessities will be provided by the bidder.
8. Security Company should be a registered entity i.e., a company, a partnership, an LLP, or a sole proprietorship, as applicable, under relevant laws. The bidder is required to have all applicable licenses, permissions and consents from the concerned authorities which are required to carry out the security services for the subject procurement.
9. The bidder should be registered with Income Tax and Sales Tax Departments (Registration number should be clearly mentioned, and valid documentary evidence should be attached). As an evidence of being an active taxpayer, relevant details of Active Taxpayer List (ATL) should be provided.
10. The bidder must submit their application along-with the following documents:
 - a. Full name, complete address, phone and fax number, email address along-with organization chart of the Company.
 - b. Number of directors/partners/proprietors (along with partnership deed or copies of articles and memorandum) giving their names, qualification and experience etc.
 - c. Complete details of clients with whom agreements were executed during last 3-years along-with the satisfactory certificate from the client.
 - d. Details of clients in hand along-with physical status of executed contract.
 - e. Undertaking that the Company has not been blacklisted or debarred by any Government/Semi Government Organization on a stamp paper of adequate value attested by the Oath Commissioner.
 - f. List of regular administrative, finance staff along-with their CVs.
 - g. Income tax clearance certificate for last 3-years, NTN No. and GST No. of the Company.
 - h. Detail of present commitments and workload with respect to financial position of the Company.
 - i. Proof of financial soundness duly supported with documentary proof, i.e. bank statement & balance sheet, sheet duly prepared by chartered accountant etc.
 - j. Documents required as per **Annexure-A**.
11. The Company should have a valid license issued by Home Department Government of the Punjab.
12. The Company shall abide by all relevant Labour Laws, Acts/Rules including but not limited to Minimum Wages Act, Employees Old Age Benefit Act, Social Security Act etc.
13. Concealment of facts will be sufficient reason for disqualification.
14. Any information/documents found deficient will not be entertained.
15. The decision of the authority as per set evaluation criteria for technical evaluation of the Company will be final.
16. The security guards are required to be ex-servicemen of Army.

17. The security guards cum supervisors should be ex-servicemen from Armed Forces and not below than the rank of Hawaladar / Sargent or equivalent.
18. Age of security guards should be between 40 years to 60 years.
19. Minimum height for security personnel should not be less than 5-ft 8-inches.
20. In-case of change in duties of security guards, security Company/ bidder will get NOC from Manager Security, QATPL or a person authorized in this behalf from time to time in writing by QATPL.
21. The contract will be enforced for a period of seven (07) Months till June 30th, 2023 which is extendable for further two years (till June 30th 2025) upon satisfactory performance and mutual consent.
22. No escalation in rate will be given during contract period.
23. QATPL shall have the right to terminate the contract at any time without assigning any reason on one month notice thereof.
24. Rate given in the tender must be inclusive of all applicable government taxes.
25. Rate must be given on tender performa attached as Annexure C, otherwise, tender will not be entertained.
26. Complete tender will be awarded to lowest bidder, if technically qualified.
27. The competent authority reserves the right to reject all tenders without assigning any reason.
28. No tender shall be entertained without Rs 90,000/- as bid security in shape of CDR.
29. The interested bidders shall submit the bid in a single package consisting of two separate sealed envelopes clearly marked as “**Technical Proposals**” and “**Financial Proposals**”, containing name of the firm/ agency, in the office of Manager Administration, Quaid-e-Azam Thermal Power Pvt. Ltd., First Floor, 7-C-1 Gulberg 3, Lahore on or before 17-10-2022 by 03.00 p.m.
30. The technical bids will be opened on the same day at 03.30 p.m. by the Procuring Committee in presence of the authorized representatives of the firms.
