TERMS OF REFERENCES (TORs) FOR PROVISION OF OFFICE STATIONERY

A. INSTRUCTION TO BIDDERS

- 1. Quaid-e-Azam Thermal Power (Pvt) Limited (QATPL) invites sealed bids for Provision of "Office Stationery" from eligible bidders through Single Stage One Envelope Procedure as per Punjab Procurement Rules, 2014 ("PPRA Rules 2014").
- 2. Income Tax and GST Registered firms / Companies are eligible to participate in this bidding process.
- 3. Bank Draft / Call Deposit as Bid Security of Rs. 15,000/- (which is within 5% of the estimated price as per rule 27 of PPRA Rules 2014) in favor of Quaid-e-Azam Thermal Power (Pvt) Limited (QATPL) must be enclosed with the sealed Bid.
- 4. Bidders shall submit their Bids in a sealed envelope on or before the Closing Date & Time i.e. <u>25-08-2020</u> by 03:00 p.m at the prescribed address of QATPL Head Office.
- 5. Bids shall be opened at **03:30 p.m** in the presence of the Bidders or their representatives who may choose to be present.
- 6. The Bidders / Firms have to submit their rates lot-wise on the basis of per unit rate (inclusive of all applicable taxes and duties etc.) in consolidated form.
- 7. The Bidders / Firms may submit their rates against any or all lots mentioned in these Bidding Documents.
- 8. No Bid shall be entertained and will be returned / rejected, if received late, open, overwritten and / or without prescribed Bid Security.
- 9. Rates will be accepted on the basis of lot-wise lowest rate; in case of difference of brands offered by the Bidders, the sample, specifications, guarantee and quality (whichever is applicable) shall be considered for evaluation and final selection.
- 10. Rates must be given on the enclosed bid performa; otherwise, Bid(s) will not be entertained and shall be rejected summarily without evaluation.
- 11. All Bids shall be evaluated on the basis of unit-rate per item for each lot and the successful Bidder shall be selected on the basis of lowest evaluated cost for each lot.
- 12. Supply Order may be issued for lot(s) found qualified as Lowest Evaluated Bidder(s).

- 13. After receiving Supply Order, Successful Bidders have to deliver orders as per approved samples within 20 days of issuance of Supply Order, failing which QATPL shall have the right to forfeit the Bid Security of Rs. 15,000/- (which is within 5% of the estimated price as per rule 27 of PPRA Rules 2014) and initiate process of black-listing of said Bidders as provided by PPRA Rules, 2014.
- 14. Successful Bidders have to supply items as per approved specifications / samples available with QATPL for reference.
- 15. Bidders may visit and inspect the samples during business hours at office of Quaid-e-Azam Thermal Power (Pvt.) Limited situated at 1st Floor, 7-C-1, Gulberg III, Lahore.
- 16. The Successful Bidder will be responsible to supply their item(s) to QATPL Head Office at its own expenses and costs, and complete in all respects as per approved specifications / samples available with QATPL for reference.
- 17. Bidders shall submit complete details of their firm, offices, along-with postal address, Phones / Fax numbers etc.
- 18. An Affidavit on original stamp paper of Rs. 100/- duly attested by the Oath Commissioner should be provided by the tenderer that their firm has never been blacklisted by any Government Department/Organization and that tenderer's acceptance of the term & conditions in this document and tender notice.
- 19. All prices must be in Pak Rupees and prices offered should be valid for 120 days from the date of opening.
- 20. The Competent Authority of QATPL can reject all Bids with or without assigning any reason prior to acceptance as PRPA Rules, 2014.
